

Unstoppable: How to Become a Wise Planner

"Anyone who listens to my teaching and follows it is wise, like a person who builds a house on solid rock. Though the rain comes in torrents and the floodwaters rise and the winds beat against that house, it won't collapse because it is built on bedrock. But anyone who hears my teaching and doesn't obey it is foolish, like a person who builds a house on sand. When the rains and floods come and the winds beat against that house, it will collapse with a mighty crash." – Matthew 7:24-27

A wise person is someone who trusts firmly in Jesus while staying aware and alert to the risks and opportunities inherent in life. And financial planning is not only wise, it's a way to cultivate a life of joy and generosity. Financial Planning 101

What does good financial planning look like? Practically speaking, it's managing risks while maximizing opportunities - or in other words, planning for the "what ifs" in life while hoping for the best. To plan well a person needs to consider several factors: What stage of life is she in? How can she prepare for her own future needs? And how can she make sure those who depend on her are cared for in the future?

Once people reach adulthood, it's usually only the wealthy who can afford financial planning services, and that creates a gap between those who can and those who can't. Kay Lynn Mayhue believes that financial literacy should begin in high school. The optimum situation would be for schools to offer financial planning courses to students so they don't end up making unwise decisions that could have consequences far into the future.

But as the saying goes, "The best time to plant a tree was twenty years ago. The second-best time is now."

The Sum is Greater than the Parts

Kay Lynn has observed that, in general, women adopt a risk management lens for thinking about the future, while men tend to worry about capitalizing on opportunities. Both perspectives in concert with each other lead to wiser financial decisions, and that's why it's important for married couples to do their financial planning together. This is so important that Kay Lynn's financial planning firm won't see one spouse without the other!

And when it comes to faith, Kay Lynn has observed another paradox. Some Jesus followers believe that Scripture teaches that faith is simply sitting and waiting for God to act. She believes that we are intended to take action on the things over which God has given us influence and then leave the results and the rest to God. This balance between faith and action is something Jesus taught us with his emphasis on trusting God while actively seeking the Kingdom:

"So, don't worry about these things, saying, 'What will we eat? What will we drink? What will we wear?' These things dominate the thoughts of unbelievers, but your heavenly Father already knows all your needs. Seek the Kingdom of God above all else, and live righteously, and he will give you everything you need." - Matthew 6:19-21, 31-33

Both in spousal relationships and faith journeys, it's important to balance caution and action and to exercise discernment. Discernment allows you to look at a situation and think about the things that could happen so you can create a plan for dealing with them if they do.

When we don't plan, we leave ourselves open to unnecessary pain in the ups and downs of life, and this can cause us to live in fear never being able to be fully present in the "now." A discerning person can look ahead and think about what might happen to her family if she was unable to support them for some reason. And the discerning person recognizes when God is nudging her to put measures in place to plan for the "what ifs" of life so she can be free to enjoy the present. Action isn't the opposite of faith, it's the natural outcome of trusting God.

Living a Life of Joy and Generosity

A good financial advisor will educate clients on their ability to be generous, because some people are too afraid to give even when they have the means. But generosity is important even before a person has extra assets to give.

Kay Lynn and her husband decided early in the life of their family to live generously despite their limited resources. Living generously required them to give up some luxuries so they could help someone else. But they were deliberate about the sacrifices they made, and they found that this posture of generosity gave their lives a foundation of meaning.

Kay Lynn advises us to pay attention to the causes to which we are drawn and give joyfully to those - even if it requires that we give up something in order to help. Then when you get to the point in your life where you have the means to make a significant difference, you'll have a foundation of generosity.

The Apostle Paul, writing to his protégé Timothy, said it this way:

"Teach those who are rich in this world not to be proud and not to trust in their money, which is so unreliable. Their trust should be in God, who richly gives us all we need for our enjoyment. Tell them to use their money to do good. They should be rich in good works and generous to those in need, always being ready to share with others. By doing this they will be storing up their treasure as a good foundation for the future so that they may experience true life." - 1 Timothy 6:17-19

Kay Lynn knows that material things don't give you true enjoyment, and seeking after short term happiness can get you into financial trouble. Her advice is to seek knowledge and wise counsel when it comes to finances. When we have good plans in place, we can be discerning about life's "what ifs" while trusting God for the things we can't control.
